PETITIONER'S MOTION TO AMEND
CASE CAPTION

IMMIGRATION HABEAS CASE

Petitioner, through counsel, respectfully moves the Court for leave to amend the case caption to correct typographical errors and update the identity of the custodian respondent. In support, Petitioner states as follows:

1. On March 4, 2026, the Court issued an Order directing Petitioner to file a motion to amend the case caption to correct certain apparent errors. (ECF No. 4).
2. The Court noted that the Petition lists “Too Lyons” as a respondent, which appears to be a typographical error. Petitioner intended to name Todd Lyons in his official capacity.
3. The Court also noted that the Petition lists “Pamala Bondi,” which appears to be a typographical error. Petitioner intended to name Pamela Bondi in her official capacity.
4. Finally, the Petition identifies Johnny Choate as the Warden of the Aurora Immigration Detention Facility. Based on publicly available information, Mr. Choate may no longer serve in that role. Petitioner therefore requests that the caption reflect the current Warden of the Aurora Contract Detention Facility in his or her official capacity.
5. Petitioner requests that the Court amend the case caption accordingly.
