**NOTICE OF RESPONDENTS' NON-COMPLIANCE WITH COURT ORDER AND REQUEST
FOR RELIEF**

1 Petitioner, through undersigned counsel, respectfully submits this Notice to inform the Court that
2 Respondents have failed to comply with this Court's March 5, 2026 Order. (ECF No. 3).

- 3 1. On March 5, 2026, this Court issued an Order requiring Respondents to file an answer or return to
4 the Petition for Writ of Habeas Corpus no later than March 13, 2026.
- 5 2. As of the date of this filing, March 18, 2026, Respondents have not filed an answer, have not filed a
6 return, have not filed any responsive pleading, and have not sought an extension of time from this
7 Court..
- 8 3. Undersigned counsel made good faith efforts to contact the Office of the United States Attorney to
9 inquire whether Respondents intended to comply with the Court's Order.
- 10 4. Respondents did not respond to counsel's communication and have provided no indication of when,
11 or whether, they intend to comply.
- 12 5. Petitioner remains detained and continues to suffer ongoing and irreparable harm as a result of
13 continued detention and Respondents' failure to comply with this Court's Order.
- 14 6. Respondents' non-compliance has delayed adjudication of this matter and has prevented the Court
15 from timely addressing Petitioner's claims. Respondents' failure to comply with a clear court-
16 ordered deadline, without explanation or request for extension, warrants immediate judicial
17 intervention.
- 18 7. In light of the ongoing constitutional violations and Respondents' failure to engage, Petitioner
19 respectfully requests that the Court proceed on an expedited basis and grant the requested relief.

24 **REQUEST FOR RELIEF**

25 Accordingly, Petitioner respectfully requests that the Court:

- 26 1. Order Respondents to immediately comply with the Court's March 5, 2026 Order;

1 3. Deem the Petition unopposed or, in the alternative, consider the Petition based on the existing
2 record;

3 4. Grant the Petition or order Petitioner's immediate release; and

4 5. Grant any further relief the Court deems just and proper.
