Mr. Nevarez Ortiz is currently detained by U.S. Immigration and Customs Enforcement (ICE) at the Otay Mesa Detention Center, San Diego, California.

He was detained on August 23, 2025, while purchasing car parts at a junkyard in San Diego, California. Mr. Nevarez Ortiz remains in custody, even though he does not have a warrant for his arrest. The petitioner has been detained for over 180 days without trial or conviction. Mr. Nevarez Ortiz does not pose a danger to the community nor is a flight risk. His continued detention is unnecessary and causes irreparable harm to his family due to him being the main provider of his family.

WHEREFORE, Petitioner respectfully requests that this Honorable Court grant this Petition and order his immediate release from ICE custody while his immigration proceedings continue.
