He was detained December 29, 2025, while on his way to work San Diego, California. As he was being arrested, officers used excessive force and physically injured the petitioner. Mr. Melena Ramirez remains in custody, even though he does not have a warrant for his arrest or a criminal record. The petitioner has been detained without trial or conviction. Mr. Melena Ramirez does not pose a danger to the community nor a flight risk. His continued detention is unnecessary and causes irreparable harm to his family.

WHEREFORE, Petitioner respectfully requests that this Honorable Court grant this Petition and order his immediate release from ICE custody while his immigration proceedings continue.
