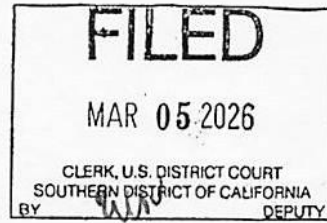

Mr. Burthnell Anthoney Hall is currently detained by U.S. Immigration and Customs Enforcement (ICE) at the Otay Mesa Detention Center, San Diego, California. He was detained on December 31, 2025, in Miami Florida, when being pulled over by police for not having a functioning light above his license plate. Mr. Anthoney Hall remains in custody even though he has not committed a federal offense and is currently in the process of resolving his immigrations matters. He works at [REDACTED] and has extended family in Miami. Mr. Anthoney Hall does not pose a danger to the community nor a flight risk. His continued detention is unnecessary and causes irreparable harm to his family.

WHEREFORE, Petitioner respectfully requests that this Honorable Court grant this Petition and order his immediate release from ICE custody while his immigration proceedings continue.
