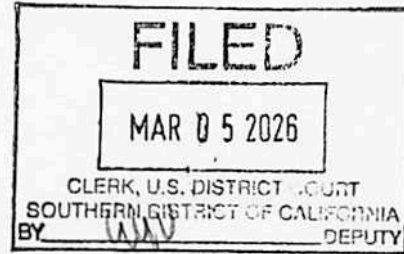

On January 26, 2026, this Court granted in part my Petition for Writ of Habeas Corpus in Case No. 25-

cv-03720-JLS-DDL. Following that Order, I received an individualized bond hearing. At the conclusion of that

hearing, the Immigration Judge denied bond, finding that I was a significant flight risk and that no bond amount would mitigate such risk. The denial of bond relied entirely on the existence of an expedited removal

order. However this determination is inconsistent with this court's findings in the Habeas Corpus Peititon.
