**EMERGENCY MOTION TO PREVENT TRANSFER AND
MOTION FOR TEMPORARY RESTRAINING ORDER**

Petitioner, YAZID SHABANA, through undersigned counsel, respectfully moves this Court for entry of an emergency order prohibiting his transfer outside the Middle District of Florida and for temporary injunctive relief and states:

1. Petitioner previously filed a pro se Petition for Writ of Habeas Corpus pursuant to 28 U.S.C. § 2241 challenging his prolonged post-order immigration detention.
2. This Court granted habeas relief and Petitioner was released from ICE custody.
3. The above-captioned matter was thereafter closed.
4. Approximately three (3) days after his release, ICE agents re-detained Petitioner.
5. Upon information and belief, ICE intends to imminently transfer Petitioner to Louisiana.
6. ICE has not identified any materially changed factual circumstances justifying renewed detention.
7. Upon information and belief, no travel documents have been secured and no receiving country has agreed to accept Petitioner.
8. The factual circumstances underlying this Court's prior habeas ruling therefore remain substantially unchanged.
9. Transfer of Petitioner outside this District would substantially impair his access to counsel and hinder enforcement of this Court's prior habeas ruling.
10. Transfer would further risk frustrating this Court's jurisdiction and rendering the previously granted habeas relief meaningless.
11. Federal courts possess inherent authority to preserve the effectiveness of their judgments and prevent actions that would interfere with pending enforcement proceedings.
12. Petitioner faces immediate and irreparable harm absent emergency injunctive relief.
13. The balance of equities strongly favors preserving the status quo pending further review by this Court.
14. The public interest favors compliance with constitutional limitations on immigration detention and preservation of judicial authority.

WHEREFORE, Petitioner respectfully requests that this Court:

- A. Enter an immediate Temporary Restraining Order Prohibiting Respondents from transferring Petitioner outside the Middle District of Florida pending further order of this Court;
- B. Alternatively, if Petitioner has already been transferred, order Respondents to immediately return Petitioner to this District;
- C. Order Respondents to maintain Petitioner within the jurisdiction of this Court pending resolution of enforcement proceedings;
- D. Direct Respondents to file a response on an expedited basis;
- E. Schedule an emergency hearing; and
- F. Grant such further relief as the Court deems just and proper.
