MOTION TO WITHDRAW PETITION FOR WRIT OF HABEAS CORPUS

AND NOW comes Petitioner, James Allan Turcios Castro, by and through the undersigned counsel, Dean Vassor, and respectfully requests that this Honorable Court grants his request to withdraw his Petitions for Writ of Habeas Corpus, because Petitioner has been removed from the United States, and is no longer in the custody of Respondents. In support of this request, Petitioner states the following:

1. On March 24, 2026, Petitioner submitted a Petition for Writ of Habeas Corpus requesting his release from detention to the United States District Court for the Eastern District of Pennsylvania. Dkt. No. 1.
2. Additionally, on March 25, 2026, Petitioner submitted an Emergency Petition for Writ of Habeas Corpus requesting his release from detention to the United States District Court for the Eastern District of Pennsylvania. Dkt. No. 2.
3. However, based on the timeline of events in Petitioner's immigration proceedings, Petitioner was removed from the United States on Sunday, March 29, 2026, and is no longer in the custody of Respondents—mooting his petitions for writ of habeas corpus.

WHEREFORE, because the underlying basis of Petitioner's writ of habeas corpus petition no longer exists, Petitioner respectfully requests that this honorable Court withdraws his previously filed Petitions for Writ of Habeas Corpus.
