GROUND TWO: Substantive due Process violation Petitioner's continued detention violates his right to substantive due process through a deprivation of the core liberty interest in freedom from bodily restraint.

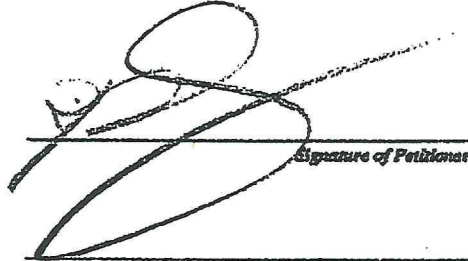
