**PETITION FOR WRIT OF HABEAS CORPUS (PRO SE)**

PURSUANT TO 28 U.S.C. § 2241

## **I. INTRODUCTION**

Petitioner, Yensi Johana Cardoza Rodriguez, acting as Next Friend of Juan Francisco Amador Guevara, respectfully petitions this Court for a Writ of Habeas Corpus pursuant to 28 U.S.C. § 2241, challenging the unlawful detention of the detainee by Immigration and Customs Enforcement (ICE).

## **II. JURISDICTION AND VENUE**

This Court has jurisdiction under 28 U.S.C. § 2241, as Petitioner challenges the legality of federal detention.

Venue is proper in the Middle District of Georgia because the detainee is currently confined at:

Irwin County Detention Center 132 Cotton Drive Ocilla, Georgia 31774.

## **III. PARTIES**

Petitioner (Next Friend):

Yensi Johana Cardoza Rodriguez Citizen of Honduras Spouse of the detainee,

Detainee:

Juan Francisco Amador Guevara A-Number  Citizen of Honduras.

Respondents:

- Warden, Irwin County Detention Center
- U.S. Immigration and Customs Enforcement (ICE)
- Department of Homeland Security (DHS).

#### **IV. FACTUAL BACKGROUND**

1. The detainee, Juan Francisco Amador-Guevara, was detained by ICE on or about March 24, 2026, at 11:30 AM, during a routine check-in appointment with immigration authorities.
2. The detainee has fully complied with all immigration requirements and court obligations.
3. The detainee has an active asylum application pending before the Immigration Court, with a scheduled hearing in the year 2027.
4. The detainee has no criminal history in:
  - The United States,
  - Honduras.
5. The detainee is a hardworking individual and father of a United States citizen child.
6. The detention was sudden and without justification, despite full compliance with immigration supervision.

#### **V. GROUNDS FOR RELIEF**

##### **1. VIOLATION OF DUE PROCESS (FIFTH AMENDMENT)**

The continued detention of the detainee violates his constitutional right to due process, as:

- He poses no flight risk,
- He poses no danger to the community,
- He has complied with all ICE check-ins.

##### **2. UNLAWFUL AND ARBITRARY DETENTION**

The detention is arbitrary because:

- There is no criminal basis,
- There is no violation of supervision,
- There is no justification for sudden custody.

### 3. UNJUSTIFIED DETENTION

The detainee remains detained despite:

- Having a pending asylum case,
- Having future court proceedings scheduled,
- Being eligible for release under supervision.

### VI. REQUEST FOR RELIEF

WHEREFORE, Petitioner respectfully requests that this Court:

1. Issue a Writ of Habeas Corpus,
2. Order Respondents to justify the detention,
3. Order the immediate release of the detainee, either:
  - Under reasonable conditions of supervision, OR
  - Without bond, if appropriate,
4. Grant any other relief the Court deems just and proper.

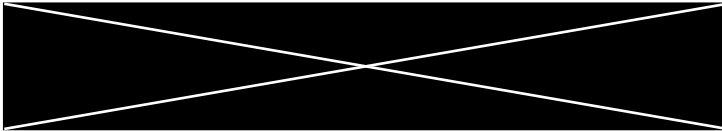


