Mr. Gutierrez-Arauz is currently detained by U.S. Immigration and Customs Enforcement (ICE) at the Otay Mesa Detention Center, San Diego, California. He was detained November 17, 2025, when ICE officers stopped his vehicle claiming to look for two other individuals who lived in the same household as the petitioner in New Jersey. As a result, ICE officers detained Gutierrez- Arauz. Mr. Gutierrez-Arauz remains in custody, even though he does not have a warrant for his arrest or a criminal record. The petitioner has been detained without trial or conviction. Mr. Gutierrez-Arauz does not pose a danger to the community nor a flight risk. His continued detention is unnecessary and unjustified.

WHEREFORE, Petitioner respectfully requests that this Honorable Court grant this Petition and order his immediate release from ICE custody while his immigration proceedings continue.
