Mr. Bastidas Silva is currently detained by U.S. Immigration and Customs Enforcement (ICE) at the Otay Mesa Detention Center, San Diego, California. He was detained on May 23, 2025 as he was leaving court and on his way home. When he was detained by ICE agents, he suffered lesions to his wrists. During his detention at Otay Mesa, he has endured food- and water-related allergies, persistent insomnia, and considerable stress. Since May 23, 2025, he has not been charged with any federal offense, and there is no pending order of removal against him.

Mr. Bastidas Silva does not pose a danger to the community nor a flight risk. His continued detention is unnecessary and unjustified.

WHEREFORE, Petitioner respectfully requests that this Honorable Court grant this Petition and order his immediate release from ICE custody while his immigration proceedings continue.
