Mr. Chiapot Perez is currently detained by U.S. Immigration and Customs Enforcement (ICE) at the Otay Mesa Detention Center, San Diego, California.

On October 9, 2025, the petitioner was detained while on his way to work in New York. While stopped at a traffic light, he was approached and taken into custody without any stated cause or legal justification.

The petitioner has resided in the United States for over 20 years and has maintained a clean record, with no prior criminal history. Despite this, he has remained in detention without being informed of any charges or provided a clear legal basis for his confinement.

Mr. Chiapot Perez remains in custody despite there not being legal justification or explanation. The petitioner's continued detention is unlawful because he was detained without probable cause or explanation and has not been formally charged with any crime.

WHEREFORE, Petitioner respectfully requests that this Honorable Court grant this Petition and order his immediate release from ICE custody while his immigration proceedings continue.

TO WHOM IT MAY CONCERN:

This letter is submitted in support of the release of Mr. Rudi Rene Chiapot Perez, currently detained by ICE at the Otay Mesa Detention Center, San Diego, California.

Mr. Chiapot Perez was detained on October 09, 2025, and currently is in the process of resolving his immigration matters.

Additional factors worth considering:

- Strong family ties in the United States and has been in the United States for 20 years.
- The petitioner is the primary caregiver and sole provider for his 17-year-old son, who suffers from chronic kidney disease and requires ongoing medical care. The petitioner plays a critical role in ensuring his son receives necessary treatment, transportation to medical appointments, and financial support. His continued detention has caused significant hardship and poses a risk to his son's health and stability.
- No danger to the community and no risk of flight.

Based on the above, we respectfully request Mr. Chiapot Perez's release on recognizance or under a minimal bond while his immigration matters are resolved.
