1 In his amended petition for a writ of habeas, Mr. Pastor-Rosales argued that
2 he was eligible for relief as a class member of *Maldonado Bautista v. Santacruz*,
3 No. 5:25-CV-01873-SSS-BFM, 2025 WL 3288403, at *9 (C.D. Cal. Nov. 25,
4 2025). In their Response, Respondents state that they “do not oppose an order
5 from this Court directing a bond hearing be held pursuant to 8 U.S.C. § 1226(a).”
6 Dkt. 7 at 1–2. Thus, this Court should order that Mr. Pastor-Rosales receive a
7 bond hearing.
