Mr. Sajquim Guillermo is currently detained by U.S. Immigration and Customs Enforcement (ICE) at the Otay Mesa Detention Center, San Diego, California.

He was detained on January 13, 2026, while attending his United States citizenship and Immigration Services appointment for fingerprints in Brooklyn, New York. He has not been formally charged of any crime and was detained without explanation.

Mr. Sajquim Guillermo remains in custody despite having active immigration relief pending. He is also in the process of renewing his work permit.

Mr. Sajquim Guillermo does not pose a danger to the community nor a flight risk. His continued detention is unnecessary and causes irreparable harm to his family.

WHEREFORE, Petitioner respectfully requests that this Honorable Court grant this Petition and order his immediate release from ICE custody while his immigration proceedings continue.
