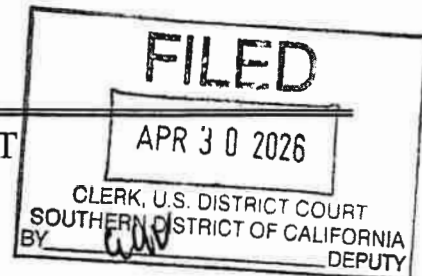

I was granted my petition of habeas corpus on 03/05/2026 by a federal judge ordering respondents to grant me a bond hearing . During the course of this hearing the immigration did not consider the argument my lawyer put forward but instead gave merits only to the argument of DHS this was unjust and unfair. This immigration judge is known to deny petitioners bond order from a federal court deeming them a flight risk without considering the evidence put forward by the petitioner meeting his or her burden of proof to overcome the flight risk bar.
