PETITION FOR WRIT OF HABEAS CORPUS


(28 U.S.C. § 2241)

I. JURISDICTION

This Court has jurisdiction pursuant to 28 U.S.C. § 2241 because Petitioner is in custody within this district.

II. CUSTODY STATUS

Petitioner,

[Calderon Gonzalez Jesus Antonio  is currently detained by U.S. Immigration and Customs Enforcement (ICE) at the Imperial Regional Detention Facility in Calexico, California.

Petitioners are in civil immigration detention and are not serving a criminal sentence.

Petitioner was denied bond by an Immigration Judge on March 2026 and has remained in custody since that time.

Petitioners have now been detained for a prolonged period without a subsequent

III. ARGUMENT

A. Prolonged detention violates due process.

B. Petitioner has not received a constitutionally sufficient bond hearing.

C. PETITIONER IS NOT A FLIGHT RISK OR DANGER TO THE COMMUNITY

Petitioners have strong community ties and support. A sponsor is available to provide Petitioner with stable housing and necessities upon release (see Exhibit A).

The sponsor has affirmed a willingness to assist Petitioner in complying with all court requirements, including attending all scheduled Immigration hearings.

Petitioner is not a danger to the community. There is no evidence suggesting that Petitioner poses any risk to public safety.

The petitioner is willing to comply with any conditions imposed by the Court, including regular check-ins, supervision, or any other requirements deemed appropriate.

Accordingly, continued detention is not necessary to ensure Petitioner's appearance or to protect the community.

D. Petitioner is willing to comply with any conditions imposed by the Court.

IV. RELIEF REQUESTED

Petitioner respectfully requests:

1. Immediate release; OR
2. A prompt individualized bond hearing.

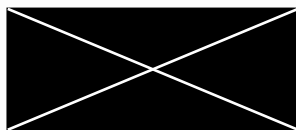
