GROUND ONE: My continued detention is unconstitutional under the 5th Amendment of the Constitution, because I have now spend over 6 months in custody and my detention is not necessary and violates the 5th and 8th Amendment of the Constitution

The six month presumtively reasonable period for continued removal period on effort has expired because he has been ordered removal since 10-6-25 for this reason petitioner's removal to Cuba or Mexico is not reasonable foreseeable because there is no immigration agreement between Cuba and the United States

GROUND TWO: Substantive due Process violation Petitioner's continued detention violates his right to substantive due process through a deprivation of the core liberty interest in freedom from bodily restraint
