**JOINT MOTION FOR ENTRY OF
STIPULATED ORDER TO REVOKE
NATURALIZATION**

22 Plaintiff, the United States of America, filed its Complaint to Revoke Naturalization against
23 defendant Rana Singh a/k/a Swaran Singh a/k/a Subaran Singh ("defendant") for alleged violations
24 of Title 8 U.S.C. §§ 1427(a)(1) and 1429. The parties have resolved all issues in this matter through
25 the attached proposed Stipulated Order for Revocation of Naturalization (the "Stipulated Order").
26 Under the terms of the Stipulated Order, defendant agrees to surrender and deliver his Certificate of
27 Naturalization No. 316165 (and any copies thereof) in his possession or control to the Attorney

1 General of the United States, or a designated representative, as well as any other indicia of U.S.
2 citizenship (including, but not limited to, United States passports and passport cards, and other
3 relevant documents).

4 The Stipulated Order is fair, reasonable, and equitable. It addresses the concerns giving rise
5 to the Complaint by modifying defendant's unlawfully procured naturalization status. Now, the
6 parties jointly and respectfully request that the Court promptly effectuate this resolution and enter
7 the proposed Stipulated Order.
